4. **BUDGET 2025-26**

Notes had been received from Mary Evans regarding the budget. These were discussed and where appropriate details amended.

a) To discuss and agree the General Purposes budget

It was clarified that Climate is the ACE Group and the budget will be changed to reflect this.

The amount earmarked for youth was questioned. The background to this was explained- that a work programme had started with the School Council who undertook a survey but the results were never received. Those who were initially interested in the project were no longer involved. It was thought that Sue Catchpole may have details, and she will be contacted.

New budget lines had been entered for CCTV and SAM2.

The full impact of the in-house grass cutting will be detailed in a report to be presented. The budget included the amount for cutting the Recreation Ground and so also included extra hours for the Groundsman. As there will be much work in the forthcoming months at the Churchyard a new cost centre for this will be created.

This cost centre also includes the Recreation Ground request which was for $\mathfrak{L}72,500$. It is noted that the Recreation Ground subsidises both cricket and bowls but not tennis. Although the Recreation Ground Committee did not feel the need to ask for the user groups accounts councillors still felt this was required as they are being funded by public money.

The Recreation Ground request was reduced by £6,000. It was not thought that £5000 for a replenishment reserve was required whilst the Town Council still holds £50,000 in reserves. The other £1000 related to the information boards as the councillors thought these could be funded via a fund-raising activity or a grant. This left the grant to the Recreation Ground at £66,500.
